How can we measure development? Recent years have witnessed concerns regarding effective management and results oriented approach to development projects and programmes. The quest for impact of development interventions has been intensified as the message "Leaving No One Behind" gets loud and clear. Participatory Monitoring and Evaluation (PM&E) is an important process that enhances relevance, effectiveness, and sustainability of development programmes. It helps organisations and institutions improve their functioning.

Participatory approaches to monitoring, evaluation, and impact assessment facilitate the active participation of the primary stakeholder, i.e., the community or the beneficiaries of the project. These approaches are also valid for organisational strengthening and institutional learning and can be applied to a diverse range of organisations.

This course on Measuring Change: Evaluating Learning and Impact offers a range of conceptual and practical issues faced by practitioners, adult educators, researchers, resource providers and policymakers in managing organisations and programmes in a participatory manner. It provides an international perspective on approaches, frameworks and models used in the field of monitoring and evaluation. The modules and activities facilitate critical analysis of different debates and perspectives on Participatory Monitoring, Evaluation and Impact Assessment in a facilitative environment.
